Board of Officers Meeting October 21, 2025

Membership Chair: Mary Ann Posanski has agreed to take Membership Chair over from Marcia. Thank you, Mary Ann. Suggestions were made that Marcia and Mary Ann plan some transitional calls to ensure a successful "passing of the baton"; and it is wise to develop a Membership team, so the entire burden is not on the shoulders of one person. At our Philadelphia meeting, there were folks who volunteered to help, and I would not want to let much time go by between their initial expression of interest and a commitment to help. We also identified people from the Greek organizations/Kuj who could be very instrumental in getting the word out to a broader audience.

Membership record-Keeping: There was a PHL attendee who claimed to be a Lifetime Member but we our records did not reflect this.
